#### **REGISTRATION PROCEDURES:**

All CSC ROII Registered Examinees of the Cancelled 15 March 2020 CSE-PPT are required to:

- Download and accomplish the Refund Request Form (RRF) (http://cscdos.rf.gd/getRRF) and the Authorization to Claim Refund Form (http://cscdos.rf.gd/getACRF), if thru representative;
- Register thru http://cscdos.rf.gd/refund starting June 21, 2021 to October 31, 2021and upload the following:
  - a. Duly accomplished RRF
  - b. Authorization to Claim Refund Form, if thru representative
  - c. Valid Identification Card of Refundee
  - d. Valid Identification Card of Authorized Representative, if applicable
  - e. Official Receipt/Acknowledgment Receipt, if available
  - <sup>f.</sup> Death Certificate (of deceased examination applicant), if applicable

**IMPORTANT :** Refundee shall register only ONCE. Absence of any of the REQUIRED
